SPECIAL SESSION - TELEPHONE CONFERENCE CALL

- CALL TO ORDER:** On November 19, 2010, at 12:05 p.m., with a quorum of the Virginia Board of Counseling ("Board") present and the Board Chair presiding, a telephone conference call was convened to consider whether a practitioner's ability to practice as a Certified Rehabilitation Provider constituted a substantial danger to the public health and safety pursuant to § 54.1-2408.1(A) of the *Code of Virginia*.

The Board received information from Mr. Halbleib in order to determine whether Mr. Britt's ability to practice as a Certified Rehabilitation Provider constituted a substantial danger to public health and safety. Mr. Halbleib provided details of the case to the Board for its consideration.

DECISION:


Upon a motion by Mr. Turner, and duly seconded by Dr. Seeman, the Board determined that the practice of Sylvester Britt as a Certified Rehabilitation Provider constituted a substantial danger to the public health and safety and voted to summarily suspend his certificate simultaneous with the institution of proceedings for a formal administrative hearing pursuant to § 54.1-2408.1(A) of the *Code of Virginia*. Further, upon a motion by Mr. Turner, and duly seconded by Ms. Bowen, the Board voted to offer to Mr. Britt a Consent Order for the indefinite suspension of his certificate in lieu of a formal administrative hearing.


With all business concluded, the Board adjourned at 12:45 p.m.




