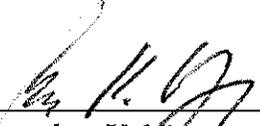

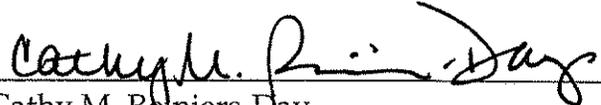
a Consent Order to New Visions Training Center subject to certain terms and conditions.

Melanie Droppleman appeared with William A. Droppleman, her husband, to discuss allegations that she may have violated certain laws and regulations governing the practice of pharmacy as stated in the May 25, 2011, Notice.
- Closed Meeting:** Upon a motion by Mr. Rhodes, and duly seconded by Ms. Shinaberry, the Committee unanimously voted to convene a closed meeting pursuant to § 2.2-3711.A(28) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Melanie Droppleman. Additionally, he moved that Cathy Reiniers-Day and Mykl Egan attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee in its deliberations.

Decision:

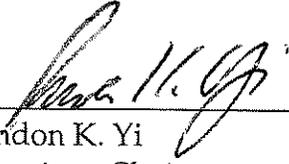

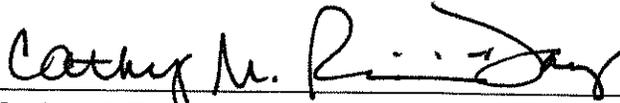
