DECISION:

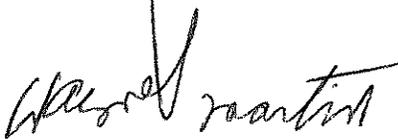

ADJOURNMENT:

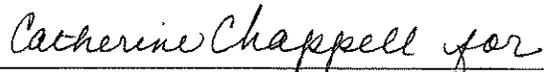
The Board adjourned the hearing on Thursday, June 24, 2010, at 1:10 a.m.
