## **Taskforce Recommendations: Implemented 2016**

- PMP registration of prescribers & dispensers
  - PMP reporting of dispensing within 24 hours (previously 7 days)
  - Mandatory check of PMP if prescribing an opioid for more than a 14 day supply
  - PMP may disclose unusual prescribing or dispensing to DHP enforcement for investigation

## **Taskforce Recommendations: Implemented 2016**

- PMP information to consulting prescribers, pharmacists
  - Board of Medicine may require 2 hours CME
  - DBHDS certification of substance abuse peer providers
  - Board of Medicine buprenorphine workgroup
  - Opioid Website

This section of VaAware is designed to assist health care professionals in the treatment of pain, prescribing of opioids, recognition and treatment of addiction, and opportunities for continuing education in all of these areas. It is managed by the Department of Health Professions, which licenses over 350,000 practitioners in more than 60 fields, including all prescribers: medical doctors, osteopaths, podiatrists, dentists, nurse practitioners, physician assistants and optometrists.

This information is critically important because there is a linear relationship between the sale of opioid pain relievers and opioid deaths (see below), and these topics (the treatment of pain, prescribing of opioids, and the recognition and treatment of addiction) have generally not been specific subject areas of medical or graduate medical education.

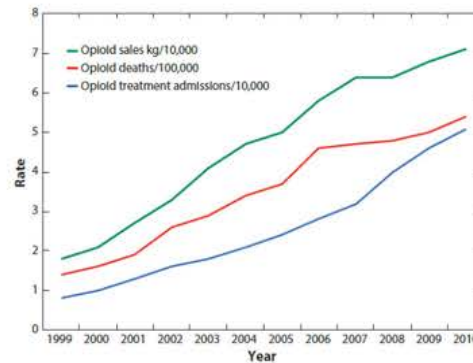


Figure 1 Rates of OPR sales, OPR-related unintentional overdose deaths, and OPR addiction treatment admissions, 1999–2010. Abbreviation: OPR, opioid pain reliever. Source: 10.
