

June 30th Renewal Information

- On March 16, 2020, the Board granted LPC, LMFT, LSATP, QMHP-A, QMHP-C and RPRS a one-year extension on the 2020 continuing education requirements.
- The chart below provides clarification as to the number of CE hours currently required for each renewal period. *Newly licensed (by examination), certified and registered individuals are **not** required to document continuing education on the first renewal date following initial licensure, certification or registration.*
- If you were not required to complete continuing education for the 2020 renewal and thus did not receive a one-year extension, you are only required to complete the minimum CE hours as outlined in the Regulations (refer to the 2022 Renewal section for the minimum requirements)
- Continuing Education used for the 2020-2021 renewal extension cannot be used again for the 2022 renewal. (A training course cannot be used for more than one renewal.)
