justified which is not within the authority of the Committee pursuant to §54.1-2400(10) of the Code of Virginia.

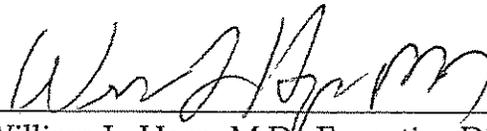
VOTE: The vote was unanimous.

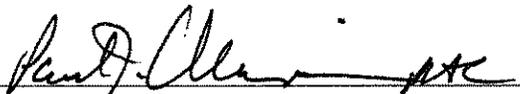
VOTE:

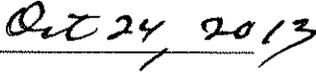

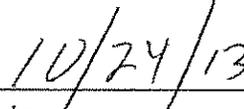
