PUBLIC COMMENT: Tahnee Causey, Genetic Counselor with VCU Medical Center is in agreement with licensure of Genetic Counselors. Ms. Causey is the individual that requested the sunrise review. Harm can be caused to patients who receive counseling from unqualified individuals. If Genetic Counselors do not receive their own board, they would accept being an advisory committee on another Board.

Heather Creswick, Genetic Counselor, VCU Massey Cancer Center. Ms. Creswick supports licensure of Genetic Counselors. Ms. Creswick stated that since other states license Genetic Counselors and Virginia does not, it makes it difficult to increase Virginia's workforce as licensed Genetic Counselors do not want to move to a state where they can not be licensed.

Christine Seward, Certified Genetic Counselor, Myriad. Ms. Seward is in favor of licensure of Genetic Counselors. Ms. Seward stated that Genetic Counselors are part of a health care


team and serve as patient advocates. She stated that title protection would not be enough to protect patients as they would not be given an avenue for voicing their concerns and complaints.

Ms. Seward will be providing the Board of Health Professions with national data on complaints received from states that license Genetic Counselors.


