**SPECIAL CONFERENCE COMMITTEE "C"**

**TIME AND PLACE:** Special Conference Committee "C" convened on June 26, 2009 at 10:02 a.m., at the Department of Health Professions, Perimeter Center, 2<sup>nd</sup> Floor Conference Center, 9960 Mayland Drive, Henrico, VA 23233.

**QUORUM:** All three members of the Committee were present.

**Dee J. Danner, D.D.S:** Dr. Danner appeared with his attorney, Nancy Reynolds, to discuss the allegations set forth in a Notice of the Board dated March 30, 2009. The Committee received statements from Dr. Danner and Ms. Reynolds and discussed the allegations with them.

**Closed Meeting:** Dr. Hall moved that the Committee convene in a closed session. The motion was seconded and passed.

**Reconvene:** Dr. Hall moved to certify that only matters lawfully exempted from open meeting requirements under Virginia law were heard, discussed or considered by the Committee. The motion was seconded and passed.

**DECISION:** Ms. Ross reported that the Committee found Dr. Danner over prepared three of Patient A's teeth causing pulp exposure and that he failed to notify the patient of the exposure; furthermore, he removed an excessive amount of enamel for the placement of crowns and veneers on six other teeth. The Committee also found that Dr. Danner failed to provide complete documentation of the treatment he rendered to Patient A.

The sanctions reported by Ms. Ross were that Dr. Danner shall receive a reprimand, complete not less than seven (7) continuing education hours in risk management and record keeping and six (6) in restorative dentistry to include crown and veneer preparation, and he shall be assessed a \$2,000 monetary penalty. Dr. Hall moved to adopt the decision of the Committee. The motion was seconded and passed.

**Approval of Minutes** Upon a motion by Dr. Hall and a second by Ms. Howard, the minutes from the Informal Conferences conducted on January 9, 2009, April 3, 2009, and May 22, 2009, were approved.
