
DECISION:

Ms. Ross reported that the Committee found Dr. Thomas failed to completely fill and obturate the canals of tooth #19 during root canal therapy on Patient A, as evidenced by a post-treatment radiograph taken on the same date of treatment.

The sanctions reported by Ms. Ross were that within 6 months from the date of entry of the Order, Dr. Thomas shall complete not less than 3 hours of continuing education in endodontics, 3 hours of continuing education in risk management, and be assessed a \$1,000 monetary penalty.


Dr. Boyd moved to adopt the decision of the Committee. The motion was seconded and passed.


ADJOURNMENT: With all business concluded, the Committee adjourned at 2:58 p.m.




