Ms. Laney reported that the Committee found that Dr. Saxena billed Patient B's insurance for a full mouth series of radiographs, despite the fact that she actually performed panoramic and bitewing radiographs.

The sanctions reported by Ms. Laney were that Dr. Saxena shall pay a \$1,000.00 monetary penalty; and that her license shall be placed on indefinite probation subject to the terms and conditions that within 6 months from the date of entry of the Order she shall be the subject of an unannounced inspection to include a random sample of 10 patient records for review.

The decision was agreed to by consensus of the Committee.
