Ms. Roukous reported that the Committee dismissed the allegations against Dr. Vendetti.

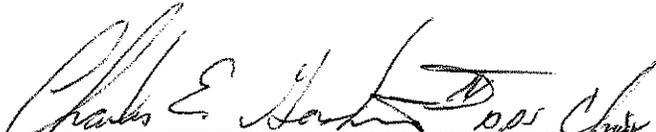
The decision was agreed to by consensus of the Committee.
