#### **REGULATORY UPDATES**

### Update to Appendix III (Itemized Statement)

The Board recently updated Appendix III to the Board's Regulations to make a correction to the FTC-required disclosure language for embalming and to clarify the Board's disclosure language related to warranties.

#### **Updates to Guidance Documents**

In 2023, the Board readopted or revised the following Guidance Documents:

**65-3**, <u>Guidelines for Processing Applications for Licensure: Examination</u>, <u>Endorsement and Reinstatement</u> (September 14, 2023)

65-4, Aiding and abetting unlicensed practice (September 14, 2023)

**65-18**, <u>Guidance on Surface Transportation & Removal Services</u> (September 28, 2023)

#### **Pending Regulatory Actions**

<u>2023 Regulatory Reduction</u> (18VAC65, Chapters 20, 30, 40) - The Board intends to reduce regulatory requirements related to the practice of funeral services, funeral directing, embalming, funeral interns, and preneed funeral planning.

Stage: NOIRA

Status: At the Secretary's Office

<u>Adjustment of requirements related to documentation of CE</u> (18VAC65-20-10 et seq.) – To align with 2022 legislation, changes the amount of time documents related to continuing education must be kept from two to three years.

Stage: Fast-Track

Status: At the Secretary's Office

Each year, the Healthcare Workforce Data Center at the Department of Health Processions (DHP) compiles a workforce report using the survey data collected from licensees during each renewal cycle. The reports capture important trends in the statewide workforce – from growth (or decline) in licensee counts to regional and statewide accessibility of care or services.
