- CLOSED SESSION:** Upon a motion by Dr. Hickman, and duly seconded by Dr. Mackler, the Committee voted to convene a closed meeting pursuant to §2.2-3711.A (27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Dr. Creef. Additionally, he moved that Ms. Deschenes and Ms. Dixon attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee in its deliberations.

RECONVENE:

Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session and announced its decision.

DECISION:

Upon a motion by Dr. Hickman, and duly seconded by Dr. Mackler, the Committee made certain findings of fact and conclusions of law and voted to deny Dr. Creef's petition for reinstatement.


VOTE:

The Committee adjourned at 1:13 p.m.




VOTE:

The Committee adjourned at 2:57 p.m.


A formal hearing will be scheduled for a future date for a final determination.
