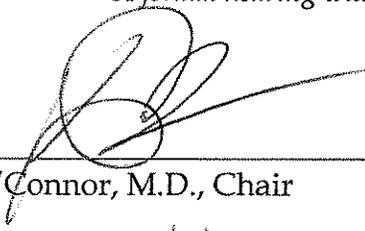
VOTE:

The Committee adjourned at 12:49 p.m.

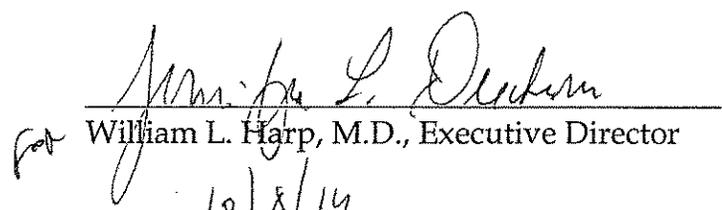
A formal hearing will be scheduled for a future date for a final determination.

ADJOURNMENT:

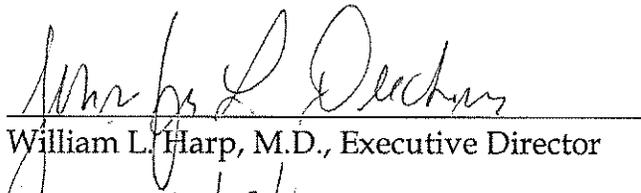
The Committee adjourned at 3:50 p.m.
