**DISCUSSION:** The Chair noted that Dr. Hagmann was not present and the time was currently 8:45 a.m. Dr. Hagmann had been noticed to appear before the Board at 8:30 a.m. Mr. Pedrotty presented an affidavit attesting that the Notice had been sent to Dr. Hagmann's address of record with the Board by overnight and first class mail. The Chair opined proper notice of the proceeding had been provided to Dr. Hagmann and the formal hearing proceeded in Dr. Hagmann's absence.

**PRELIMINARY MATTER** In Respondent's absence, the panel considered Respondent's motion to recuse the Chair that had been submitted prior to the Formal Hearing. The vote was unanimous (7 - 0) to retain Dr. O'Connor as Chair.

Following this, Formal Hearing Exhibits submitted by the Commonwealth were entered into evidence and the Board received sworn testimony from witnesses called by the Commonwealth.

Formal Hearing Exhibits previously submitted by the Respondent were admitted into evidence.

**CLOSED SESSION:** Upon a motion by Dr. Allison-Bryan, and duly seconded by Dr. Ali, the Board voted to convene a closed meeting pursuant to §2.2-3711.A (27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Dr. Hagmann. Additionally, Dr. Allison-Bryan moved that Ms. Barrett, Ms. Deschenes and Ms. Wood attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Board in its deliberations.

**RECONVENE:** Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Board re-convened in open session and announced its decision.

**DECISION:** Upon a motion by Dr. Ali, and duly seconded by Dr. Allison-Bryan, the Board voted to revoke the medical license of John H. Hagmann, M.D.

**VOTE:** The vote was unanimous.

**ADJOURNMENT:**

The Board adjourned at 5:21 pm.
