$+ \mathbf{P}$ ERINATAL AND OTHER DEPRESSION IN WOMEN

The 2020 Session of the General Assembly passed HB 42 which requires the Board of Medicine to "annually issue a communication to every practitioner licensed by the Board who provides primary, maternity, obstetrical, or gynecological health care services reiterating the standard of care pertaining to prenatal or postnatal depression or other depression. Such communication shall encourage practitioners to screen every patient who is pregnant or who has been pregnant within the previous five years for prenatal or postnatal depression or other depression, as clinically appropriate and shall provide information to practitioners regarding the factors that may increase susceptibility of certain patients to prenatal or postnatal depression or other depression or other depression, including racial and economic disparities, and encourage providers to remain cognizant of the increased risk of depression for such patients."

HB 42 echoes the recommendation of the 2016 US Preventive Services Task Force that pregnant women and postpartum women should be screened for depression, and it adds women that have been pregnant in the last 5 years. The bill seeks to be preventive, so it encourages practitioners to identify women at risk for depression. Screening and identification is important since many women do not seek treatment for depression. The practitioner is in the important position of being able to refer women at risk for depression to counseling and for further evaluation. This initiative is particularly relevant for minority women, a group that has not been screened as often.

Remember that postpartum depression can cause intense feelings of sadness, anxiety or despair that prevent new mothers from being able to do their daily tasks. Practitioners should be aware of the risk factors for perinatal depression, factors that can be clinical or social. Here are some to keep in mind.

Clinical Risk Factors

- Personal or family history of depression
- History of physical or sexual abuse
- Unplanned or unwanted pregnancy
- Current stressful life events
- Pregestational or gestational diabetes
- Complications during pregnancy



Social Risk Factors

- Low socioeconomic status
- Lack of social or financial support
- Adolescent parenthood

Additionally, you should know that 1 in 7 women has perinatal depression. Preexisting depression, psychiatric illness prior to pregnancy, and symptoms during pregnancy are the strongest predictors of perinatal depression. Data show that a previous episode of postpartum depression predicts a second episode 50% of the time. A previous episode of postpartum psychosis predicts a recurrence 80-90% of the time. African-American women meet criteria for depression more than other ethnic groups and are 3 times more likely to die from pregnancy-related causes. And 1 in 3 migrant women from low and middle income countries have perinatal mental health issues.

It is recommended that women who exhibit 1 or more of the following should be referred for counseling or further evaluation.

- History of depression
- Current depressive symptoms
- Low income
- Adolescent or single parenthood
- Recent intimate partner violence
- Elevated anxiety symptoms
- History of significant negative life events

A useful tool to help with the identification of postpartum depression is the Edinburgh Postnatal Depression Scale. You can find it at:

The following 2 questions are recommended as a quick screen for a past history of depression, a significant risk factor. If the answers are "yes" for a pregnant or postpartum woman, consider referral for counseling or further evaluation.



- Was there ever a period of time when you were feeling depressed or down or when you lost interest in pleasurable activities most of the day, nearly every day, for at least 2 weeks?
- Has a health care professional ever told you that you were depressed? Have you ever taken a medication for depression?

In all cases, interventions should be tailored to the risk.

As of July 1, 2020, law requires that all prescriptions containing an opioid be transmitted to a pharmacy electronically. The law provides for a 1-year waiver of this requirement for demonstrated economic hardship, technological limitations beyond the control of the licensee, or other exceptional circumstances. To date, almost 2,000 waiver requests have been reviewed. Most requestors have been granted waivers. Some have been asked to submit more information to "demonstrate" 1 of the 3 reasons that a waiver is to be granted. If you are requesting a waiver, be sure to include a description that "demonstrates" why you need a waiver.

<u>NOTE BENE</u>: ALL WAIVERS FOR THIS REQUIREMENT EXPIRE AT MIDNIGHT ON JUNE 30, 2021. ALL PRESCRIBERS <u>MUST</u> TRANSMIT PRESCRIPTIONS CONTAINING AN OPIOID ELECTRONICALLY AS OF JULY 1, 2021.


<u>HB 115 Health care providers, certain; program to address career fatigue and wellness, civil immunity.</u>

Programs to address career fatigue and wellness in certain health care providers; civil immunity. Expands civil immunity for health care professionals serving as members of or consultants to entities that function primarily to review, evaluate, or make recommendations related to health care services to include health care professionals serving as members of or consultants to entities that function primarily to address issues related to career fatigue and wellness in health care professionals licensed to practice medicine or osteopathic medicine or licensed as a physician assistant. The bill also clarifies that, absent evidence indicating a reasonable probability that a health care professional who is a participant in a professional program to address issues related to career fatigue or wellness is not competent to continue in practice or is a danger to himself, his patients, or the public, participation in such a professional program does not trigger the requirement that the health care professional be reported to the Department of Health Professions. HB 386 Conversion therapy; prohibited by certain health care providers.

Department of Health Professions; conversion therapy prohibited. Prohibits any health care provider or person who performs counseling as part of his training for any profession licensed by a regulatory board of the Department of Health Professions from engaging in conversion therapy, as defined in the bill, with any person under 18 years of age and provides that such counseling constitutes unprofessional conduct and is grounds for disciplinary action. The bill provides that no state funds shall be expended for the purpose of conducting conversion therapy with a person under 18 years of age, referring a person under 18 years of age for conversion therapy, or extending health benefits coverage for conversion therapy with a person under 18 years of age. This bill is identical to <u>SB 245.</u>

HB 471 Health professionals; unprofessional conduct, reporting.

Health professionals; unprofessional conduct; reporting. Requires the chief executive officer and the chief of staff of every hospital or other health care institution in the Commonwealth, the director of every licensed home health or hospice organization, the director of every accredited home health organization exempt from licensure, the administrator of every licensed assisted living facility, and the administrator of every provider licensed by the Department of Behavioral Health and Developmental Services in the Commonwealth to report to the Department of Health Professions any information of which he may become aware in his professional capacity that indicates a reasonable belief that a health care provider is in need of treatment or has been admitted as a patient for treatment of substance abuse or psychiatric illness that may render the health professional a danger to himself, the public, or his patients, or that he determines, following review and any necessary investigation or consultation with the appropriate internal boards or committees authorized to impose disciplinary action on a health professional, indicates that there is a reasonable probability that such health professional may have engaged in unethical, fraudulent, or unprofessional conduct. Current law requires information to be reported if the information indicates, after reasonable investigation and consultation with the appropriate internal boards or committees authorized to impose disciplinary action on a health professional, a reasonable probability that such health professional may have engaged in unethical, fraudulent, or unprofessional conduct. This bill is identical to SB 540.

<u>HB 648 Prescription Monitoring Program; information disclosed to Emergency</u> <u>Department Care Coord. Program.</u>

Prescription Monitoring Program; information disclosed to the Emergency Department Care Coordination Program; redisclosure. Provides for the mutual exchange of information between the Prescription Monitoring Program and the Emergency Department Care Coordination Program and clarifies that nothing shall prohibit the redisclosure of confidential information from the Prescription Monitoring Program or any data or reports produced by the Prescription Monitoring Program disclosed to the Emergency Department Care Coordination Program to a prescriber in an electronic report generated by the Emergency Department Care Coordination Program so long as the electronic report complies with relevant federal law and regulations governing privacy of health information. This bill is identical to <u>SB 575.</u>

HB 1000 Prescription drugs; expedited partner therapy, labels.

Prescription drugs; expedited partner therapy; labels. Eliminates the requirement that a bona fide practitioner-patient relationship exist with a contact patient for a practitioner to prescribe expedited partner therapy consistent with the recommendations of the Centers for Disease Control and Prevention. A pharmacist dispensing a Schedule III through VI drug to a contact patient whose name and address are unavailable shall affix "Expedited Partner Therapy" or "EPT" to the written prescription and the label. The bill repeals the July 1, 2020, sunset on the provision that allows practitioners employed by the Department of Health to prescribe antibiotic therapy to the sexual partner of a patient diagnosed with a sexually transmitted disease without the physical examination normally required. https://lis.virginia.gov/cgi-bin/legp604.exe?201+ful+CHAP0464

HB 1059 Certified registered nurse anesthetists; prescriptive authority.

Certified registered nurse anesthetists; prescriptive authority. Authorizes certified registered nurse anesthetists to prescribe Schedule II through Schedule VI controlled substances and devices to a patient requiring anesthesia as part of the periprocedural care of the patient, provided that such prescribing is in accordance with requirements for practice by certified registered nurse anesthetists and is done under the supervision of a doctor of medicine, osteopathy, podiatry, or dentistry. 
HB 1084 Surgical assistants; definition, licensure.

Surgical assistants; licensure. Defines "surgical assistant" and "practice of surgical assisting" and directs the Board of Medicine to establish criteria for the licensure of surgical assistants. Currently, the Board may issue a registration as a surgical assistant to eligible individuals. The bill clarifies that requiring the licensure of surgical assistants shall not be construed as prohibiting any professional licensed, certified, or registered by a health regulatory board from acting within the scope of his practice. The bill also establishes the Advisory Board on Surgical Assisting to assist the Board of Medicine regarding the establishment of qualifications for and regulation of licensed surgical assistants

HB 1328 Offender medical & mental health information & records; exchange of information to facility, etc.

Exchange of offender medical and mental health information and records. Provides that a health care provider who has been notified that a person to whom he has provided services within the last two years is committed to a local or regional correctional facility shall, upon request by the local or regional correctional facility, disclose to the local or



regional correctional facility where the person is committed any information necessary to ensure the continuity of care of the person committed. The bill also provides protection from civil liability for such health care provider, absent bad faith or malicious intent. 
HB 1506 Pharmacists; initiating of treatment with and dispensing and administering of controlled substances.

Pharmacists; prescribing, dispensing, and administration of controlled substances. Allows a pharmacist to initiate treatment with and dispense and administer certain drugs and devices to persons 18 years of age or older in accordance with a statewide protocol developed by the Board of Pharmacy in collaboration with the Board of Medicine and the Department of Health. The bill directs the Board of Pharmacy to establish such protocols by November 1, 2020, to promulgate emergency regulations to implement the provisions of the bill, and to convene a work group to provide recommendations regarding the development of protocols for the initiating of treatment with and dispensing and administering of additional drugs and devices for persons 18 years of age and older. The bill also clarifies that an accident and sickness insurance policy that provides reimbursement for a service that may be legally performed by a licensed pharmacist shall provide reimbursement for the initiating of treatment with and dispensing and administration of controlled substances by a pharmacist when such initiating of treatment with or dispensing or administration is in accordance with regulations of the Board of Pharmacy. https://lis.virginia.gov/cgi-bin/legp604.exe?201+ful+CHAP0731

SB 757 Medical Excellence Zone Program; VDH to determine feasibility of establishment.

Department of Health; Department of Health Professions Medical Excellence Zone Program; telemedicine; reciprocal agreements. Directs the Department of Health to determine the feasibility of establishing a Medical Excellence Zone Program to allow citizens of the Commonwealth living in rural underserved areas to receive medical treatment via telemedicine services from providers licensed or registered in a state that is contiguous with the Commonwealth and directs the Department of Health Professions to pursue reciprocal agreements with such states for licensure for certain primary care practitioners licensed by the Board of Medicine. The bill requires the Department of Health to set out the criteria that would be required for a locality or group of localities in the Commonwealth to be eligible for the designation as a medical excellence zone and report its findings to the Senate Committee on Education and Health and the House Committee on Health, Welfare and Institutions by November 1, 2020.

The bill states that reciprocal agreements with states that are contiguous with the Commonwealth for the licensure of doctors of medicine, doctors of osteopathic medicine,



physician assistants, and nurse practitioners shall only require that a person hold a current, unrestricted license in the other jurisdiction and that no grounds exist for denial based on the acts of unprofessional conduct. The Department of Health Professions is required to report on its progress in establishing such agreements to the Senate Committee on Education and Health and the House Committee on Health, Welfare and Institutions by November 1, 2020. The bill requires the Board of Medicine to prioritize applications for licensure by endorsement as a doctor of medicine or osteopathic medicine, a physician assistant, or a nurse practitioner from such states through a streamlined process with a final determination regarding qualification to be made within 20 days of the receipt of a completed application. This bill is identical to <u>HB 1701.</u>

SB 976 Pharmaceutical processors; operation of cannabis dispensing facilities.

Board of Pharmacy; pharmaceutical processors; cannabis dispensing facilities. Defines "cannabis dispensing facilities" and allows the Board of Pharmacy to issue up to five permits for cannabis dispensing facilities per health service area. The bill requires the Board to establish a ratio of one pharmacist for every six pharmacy interns, technicians, and technician trainees for pharmaceutical processors and cannabis dispensing facilities. The bill directs the Board of Pharmacy to require that, after processing and before dispensing cannabis oil, a pharmaceutical processor make a sample available from each homogenized batch of product for testing at an independent laboratory located in Virginia that meets Board requirements. The bill requires that the Board promulgate regulations that include an allowance for the sale of devices for administration of dispensed products and an allowance for the use and distribution of inert product samples containing no cannabinoids for patient demonstration exclusively at the pharmaceutical processor or cannabis dispensing facility, and not for further distribution or sale, without the need for a written certification. The bill also requires the Board to adopt regulations for pharmaceutical processors that include requirements for (i) processes for safely and securely cultivating cannabis plants intended for producing cannabis oil; (ii) a maximum number of marijuana plants a pharmaceutical processor may possess at any one time; (iii) the secure disposal of plant remains; (iv) dosage limitations, which shall provide that each dispensed dose of cannabis oil not exceed 10 milligrams of tetrahydrocannabinol; and (v) a process for registering cannabis oil products. The bill requires the Board of Pharmacy to promulaate required regulations within 280 days of the bill's enactment. https://lis.virginia.gov/cgi-bin/legp604.exe?201+ful+CHAP1278

On March 25th, Norman Oliver, MD sent a message to all prescribers in the Commonwealth regarding chloroquine, hydroxychloroquine, mefloquine and azithromycin. Dr. Oliver's message provides guidelines for their use at this time. Overprescribing of these drugs could

$\mathbf{A} \mathbf{N}$ ew regulations underway

- Regulations on the prohibition of Conversion Therapy were published in the Virginia Register of Regulations on August 6, 2020. The public comment period closed September 30, 2020. Here is the <u>link</u> to the Virginia Register.

- Final regulations on waivers for e-prescribing of medications containing an opioid are in progress to replace the emergency regulations. Here is the proposed text:

18VAC85-21-21. Electronic prescribing

A. Beginning July 1, 2020, a prescription for a controlled substance that contains an opioid shall be issued as an electronic prescription consistent with § 54.1-3408.02 of the Code of Virginia.

B. Upon written request, the board may grant a one-time waiver of the requirement of subsection A of this section for a period not to exceed one year due to demonstrated economic hardship, technological limitations that are not reasonably within the control of the prescriber, or other exceptional circumstances demonstrated by the prescriber.

- Fast-Track Regulations to allow a respiratory therapist to allow 20 hours of continuing education (CE) credit for passage of a specialty examination of the National Board of Respiratory Care in the biennium in which the practitioner passed the exam are in the final stages. Here is the proposed text:

18VAC85-40-66 Continuing education requirements

4. Passage of a specialty examination of the National Board of Respiratory Care for 20 hours of credit in the biennium in which the examination was passed.

- Regulations concerning the practice of physician assistants on patient care teams were published in the Virginia Register of Regulations on August 31, 2020. The public comment period ended on October 30, 2020. Here is the <u>link</u> to the proposed text.

- Regulations for the licensure and regulation of surgical assistants are being developed with the Advisory Board on Surgical Assisting.



LEPARTMENT OF HEALTH PROFESSIONS WORK GROUPS

The Board of Pharmacy, with input from the Board of Medicine, is developing protocols for pharmacists to initiate treatment for certain conditions in individuals 18 and over. The medications being considered to treat a number of conditions are naloxone or other opioid antagonists, epinephrine, prenatal vitamins, injectable or self-administered hormonal contraceptives, HIV medications, flu shots, PPD testing, and tobacco cessation therapy. There have been 3 extremely productive meetings to date.

The Boards of Psychology, Social Work and Counseling, along with the Board of Medicine, are studying the issue of mental health providers declining to provide treatment to minors for anticipated forensic issues.

The Board of Optometry TPA Formulary Committee, with input from the Board of Medicine, met to consider the addition of Upneeq, an alpha-adrenergic agonist, to the optometry TPA list to treat acquired blepharoptosis.

Pursuant to SB757 and HB1701, Board of Medicine staff is talking with Virginia's surrounding states to see if there is interest in developing reciprocal licensing agreements.

During the COVID-19 pandemic, the Board of Medicine has expedited the licensure of MD's, DO's, DPM's, PA's and RT's. Certain requirements for primary-source documents have been waived, and staff has obtained some documentation for applicants, such as reports from the National Practitioner Data Bank. Additionally, licensees in the 5 expedited professions that held an active license within the last 4 years can reactivate or reinstate their license with no fee or continuing education requirement.

Executive Order 57

Governor Northam's Executive Order 57 allowed practice by out-of-state health care professionals and expanded authority for physician assistants, nurse practitioners, interns/residents/fellows/senior medical students, and waived the examination for graduate respiratory therapists until it became available again.

4 PAPERLESS LICENSING

The Department of Health Professions is moving towards paperless licensing. The 2020 & 2021 renewal cycles will be the last time paper licenses are issued. With your renewal notice in 2020 & 2021, there will be information indicating that this will be the last hard copy you will be issued, along with instructions that the current status of your license can be found on License Lookup at: https://dhp.virginiainteractive.org/Lookup/Index All hospitals, health care organizations, employers and others can be directed to License Lookup for the real-time status of a license. Going forward, notification renewals will also be paperless. Be sure that the Board of Medicine has your correct email address to send the e-notification. Only those that do not have an email address will be sent a paper notification.

AIDWIVES AND FETAL DEATH REPORTS

The Advisory Board on Midwifery requested that an item concerning stillbirths and the process to follow be included in the Board Briefs. By law, all fetal deaths must be reported. Here is the <u>law</u> governing the reporting of fetal death.

+ Surgical assistant licensing

Congratulations to the professionals in surgical assisting. Here is how the transition from registration to licensing will occur.

All surgical assistants in current, active registration status with the Board will automatically be transitioned to Licensed Surgical Assistants in the Board of Medicine's database. No application to effect this change will be required.

Wall certificates for the group above (current active registrants) will be printed and sent, designating them as Licensed Surgical Assistants.

At renewal time, licensees will need to fill out a renewal form and submit a fee.

All surgical assistants not currently registered with the Board of Medicine will need to fill out an application and submit a fee.



New way for healthcare providers to report suspected child abuse and NEGLECT

As you know, Virginia law requires that all individuals licensed to practice medicine or one of the healing arts to immediately report concerns of suspected child abuse and neglect. The Virginia Department of Social Services' (VDSS) Division of Family Services (DFS) has developed a new Mandated Reporter Portal, which provides a streamlined and easily accessible way for Mandated Reporters in Virginia to submit reports of suspected abuse and neglect. Data from the Mandated Reporter Portal securely transmits the information to VDSS Hotline staff for review. The Portal can be accessed at https://vacps.dss.virginia.gov/.
